Subject : Request to initiate investigation into attacks and torture, including testing and experiments, by citizens in the Netherlands with Directed Energy Weapons

Dear,

As you are undoubtedly aware, there has been an uproar in the United States since 2016 about the Havana Syndrome: American and Canadian diplomats, their children and security personnel, including CIA personnel, who have been attacked with (Radio Frequency) Directed Energy Weapons.

These weapons are also used against civilians, including in the Netherlands, with reports of victims dating back to the 1990s. These weapons are not new and were discussed in the European Parliament in the late 1990s. At the time, there were calls for treaties to regulate the use of these weapons, which can easily be used to torture people, but these treaties were never established.

The use of these weapons against civilians has been kept secret for years. When civilians reported this, they were dismissed as fantasists and often labeled as having a psychosis.

However, with all the information about Havana Syndrome that has now become available, it can no longer be denied that these weapons exist and have been used for about thirty years. Some 1,500 American diplomats and security personnel have reported these attacks, and more than 300 have now been treated in military hospitals. I refer here to all the information about Havana Syndrome, including the Homeland Security hearing of May 8, 2024, interviews with the victims, and the research by the National Academies of Sciences, Engineering, Medicine, which concluded in 2020 that the most plausible explanation is 'directed pulsed radio frequency energy', in other words: focused pulsed microwaves, compare RADAR. Much information is still secret, and the CIA is accused of suppressing the truth. The latest information (as of January 19, 2025) is that two departments within the Intelligence Community now acknowledge that other countries may have weapons capable of causing such symptoms.

I would like to point out that there are different types of Directed Energy Weapons, which depending on the frequency, intensity and duration, can cause all sorts of different symptoms, including headaches, nausea, neurological problems, heart problems, pressure, burping, farting, sneezing, convulsions, organ pain, burning sensations, the feeling of being boiled alive, and even hearing voices. High intensities as well as low intensities, short and long term, can be used to torture someone.

In addition, these weapons can be used to create sounds, for example a 'kettle pop', a 'pop' in a plastic window frame, or television, a roof, by shooting an energy beam at it.

More information about these weapons:

- These weapons can be big, but also small. In the latter case they fit in a backpack, a suitcase, a car.
- The radiation from some of these weapons passes through 'building materials', so the walls of a house offer no protection.
- The radiation from some of these weapons is targeted, so someone can be attacked with them while the person next to them is not affected.
- Attacks can also come from the air. Many military aircraft/drones are equipped with RADAR systems and/or electronic warfare equipment.

- These weapons can therefore be used anywhere (indoors and outdoors) for psychological torture and physical torture (also through attacks, tests, experiments). And all this often without leaving visible evidence.
- These weapons can be used stand-alone or as part of a larger weapon system.
- Operation can be partly automated, but can also be manual using simple equipment such as a mobile phone or laptop.
- These weapons can be operated on Dutch territory, but can also be operated from other countries.
- These weapons can be part of multifunctional surveillance equipment, where 'eavesdropping' and 'attacking' are combined in one device.

Government documents show that there are agreements between Defense and/or the MIVD on the one hand and American government organizations or private companies on the other. An example is the MEMORANDUM OF UNDERSTANDING BETWEEN THE DEPARTMENT OF DEFENSE OF THE UNITED STATES OF AMERICA AND THE MINISTER OF DEFENCE OF THE KINGDOM OF THE NETHERLANDS FOR TEST AND EVALUATION PROGRAM (TEP) COOPERATION (SHORT TITLE: TEP MOU) of 2004. But there are undoubtedly many more agreements. These agreements often only provide the framework, but do not contain details of what exactly has been agreed, what exactly is being done.

However, the CTIVD does have access to this information and can therefore test these agreements against Dutch law and the treaties to which the Netherlands is bound, including the ECHR (European Convention on Human Rights), the ICC Rome Statute and the United Nations Convention against Torture.

This assessment should not only be carried out for Dutch individuals, groups and organisations, but also for all foreign individuals, groups and organisations insofar as they are located on Dutch territory.

I would like to point out to you, perhaps unnecessarily, that the United States offers much less legal protection to its own citizens, but that individuals, groups, government organizations and private organizations from the United States are also bound by the aforementioned Dutch laws and treaties on Dutch territory.

You can further investigate whether the equipment installed on Dutch territory is multifunctional (see above) and can be operated from other countries, and if so, how this is done.

The suffering of mostly innocent civilians, without criminal records, who are attacked and tortured with Directed Energy Weapons is enormous. These are very serious crimes. Human rights are violated in horrific ways, sometimes resulting in death. For many victims, the attacks are not one-off or short-lived, but start one day and never end. These are atrocities unparalleled in history.

So far there is no help, the police say they can't do anything at the moment, there is no protection for citizens.

On February 9, 2022, the STOPEG Foundation sent a letter with the subject 'Stopping attacks and torture with Directed Energy Weapons' to Mr. H. van Essen (Chief of Police), Dutch Police.

Since no response was received, not even after a reminder, Stichting STOPEG sent a letter with the subject 'Stopping attacks and torture with Directed energy weapons' to the Minister of Justice Dilan Yeşilgöz-Zegerius on November 30, 2022. This letter was co-signed by 20 victims from the Netherlands, whose details are known to Stichting STOPEG. A response to this letter was received from the Minister of Justice on February 1, 2023, Program Manager MB Haas. The minister's response is that attention is being paid to the electric shock weapon (taser), and that the minister currently sees no reason to initiate an investigation into the use of other possible weapons. So there are 'new' weapons, but the government does nothing. A disgrace!

On May 22, 2023, the STOPEG Foundation sent a letter to the College for Human Rights. They too could do nothing for the victims.


